Pastor led us in prayer.

The Financial Report was given by Judy. The building fund looks great. The general fund is in need of some attention. She mentioned that income typically increases as the calendar year comes to an end. Tyler made a motion to approve the report. Lori seconded. Motion carried.



RURAL CHURCH FELLOWSHIP CROP WALK 2025




